



## Ss. Peter & Paul School Council Application

**Purpose:** This Board, in its advisory capacity, shall formulate and recommend to the pastor and principal policies for Catholic education in Ss. Peter & Paul Catholic School. The Board shall be subject to the authority of the Church as represented by the Diocesan Office of Education and, within the parish, by the pastor and principal.

### **Function of the Board:**

1. Recommend the implementation of the policies of the Diocesan Office of Education.
2. Develop an annual budget, in conjunction with the Parish Council and recommend its approval to the pastor.
3. Determine annual tuition and any other school fees.
4. Develop and recommend policies regarding educational curricula, student discipline, extra-curricular activities and uniform code.
5. Undertake long-range planning to meet the future needs of the classroom facilities and equipment, and evaluate and review existing facilities and equipment.
6. Establish such committees as are necessary to complete the work of the board and/ or as requested by the pastor.

*Article II -Purpose and Function of the Board*

*By-laws – Ss. Peter & Paul Catholic School Board of Education*

Nominees for appointment to Ss. Peter & Paul Catholic School Council shall be selected in light of the following qualifications:

### **Personal:**

- An inquiring mind – open to both sides of an issue
- The highest level of honesty, integrity and prudence.
- Ability to act without bias toward faculty and other employees of the school
- The courage to face unpleasant tasks or decisions
- Ability to be very objective

### **Professional**

- A commitment to the importance of service to the parish community
- The ability to influence public opinion favorably in areas of importance to the school
- A willingness to balance a prudent concern for fiscal stability with a spirit of creative risk-taking
- A willingness to learn while preparing for and serving as a council member.

### **Council:**

- A commitment to understand and support the mission of the school
- A willingness to serve within the philosophy and directive structures of the council,
- An appreciation for maintenance of confidentiality in matters pertaining to the council and the school
- A willingness to support council decisions even if he-she does not fully agree.
